New Year = New Option for Certification Testing

Live Online Proctored Test Administration - New!



HFMA now offers secure, live, internet-based test administration for Certified Healthcare Financial Professional (CHFP) exam candidates. This new service is in addition to the internet-based test administration at Castle's Proctored Test Sites. Through the Castle Worldwide online test scheduling system, a candidate may elect to test

via a live, online proctored testing session.

The new Live, online proctoring service is available 24/7/365 for scheduling and exam delivery [based on the availability of proctors]. **Candidates can schedule their exam at any hour of the day, any day of the week!** Live, online proctoring eliminates the inconvenience of travel time and costs, and allows for more flexibility.

Candidates are responsible for ensuring their testing environment meets the minimum requirements to take the examination. The following are minimum technical requirements:

- A well-working computer with 1 GB of RAM or higher
- A high-speed internet connection (3MBps). Wireless is acceptable; however a wiredconnection is preferred
- A webcam with 640×480 video pixel resolution (a laptop camera is acceptable)
- Working speakers connected to the computer
- A microphone connected to the computer (consider a webcam with a built-in microphone)
- Flash player version 7 or higher
- Browser compatibility: IE, Firefox, Chrome, Safari

Of course there is still the option of taking the exam at a Castle Worldwide Proctored Test Center. The majority of Castle Worldwide sites are open for testing Monday through Saturday during normal business hours. Exam candidates may select a date and time based on site availability during exam scheduling.

Program Recaps

Healthcare Economics & Innovation Strategies Cleveland Convention Center - November 14, 2013

On Thursday November 14th, the chapter hosted a program entitled "Healthcare Economics & Innovation Strategies" in the area's new premier meeting space, the Cleveland Convention Center. Thomas Campanella from Baldwin Wallace started the day with a presentation about Healthcare Economic Strategies. He stressed how the current economics of the healthcare industry are shaped by payment methods. High costs are prevalent because current Medicare and Medicaid payments reimburse

providers for high utilization. As the Affordable Care Act increases the focus on wellness and preventive care, hospitals and physicians will need to create innovative solutions to fulfill patient care needs while reducing overall utilization.

J.B. Silvers, PhD. was next with his presentation on Innovative Change. Mr. Silvers compared the evolving healthcare market to Newton's laws of physics. The principle of speed of change being impacted by the force applied to mass was presented in the context of the powerful forces of ACA and consumerism leading to significant changes.

A session led by Ken Leonczyk from The Advisory Board focused on helping providers improve financial performance. His Sustainable Acute Care Enterprise discussion included several recommendations for reducing costs by reviewing operations of all facility cost centers.

Dr. Mark Froimson, President of Euclid Hospital, shared thoughts on managing episodes of care. He led a Cleveland Clinic initiative focused on engaging surgical patients and their caregivers from seven days pre-procedure to thirty days following treatment. This approach was driven be a new bundled payment strategy being refined by CMS.

Concluding the education was John Augustine, Chief Market Strategist with Fifth Third Bank. He provided a thorough overview of the economy at the national and state level before focusing on healthcare trends. Mr. Augustine also described changes in the Ohio and national workforce and their impact on financial market performance.

Attendees were then treated to a tour of the Cleveland Convention Center and Global Center for Health Innovation. The new Cleveland Convention Center includes 225,000 gross square feet of Class A exhibit space divisible into three exhibition halls, 35 meeting rooms, expansive truck loading dock, and a 32,000-square-foot, column-free ballroom with spectacular views of Cleveland's lakefront.

The Global Center for Health Innovation serves health and health care innovation, technology, education and commerce through state-of-the-art spaces, programs and virtual offerings. The center features four themed floors: Health and Home on the first floor, highlighted by the State-of-the-Art Patient Home; People, Patients and Caregivers on the second floor; Clinical Spaces on the third floor; and Health Care information technology on the fourth floor. All areas will be open to the general public in mid-2014.

The Founders Merit Award Series encourages continuous active participation at the local and national levels based on the following point system.

The William G. Follmer Bronze Award is awarded after an individual has earned 25 member points. This award is named after William G. Follmer, who is credited with the creation of the American Association of Hospital Accountants (AAHA) (now HFMA).

The Robert H. Reeves Silver Award is awarded to an individual who has earned 50 total member points. Reeves, an organizing member of the AAHA, was elected president of AAHA in 1956 and was instrumental in creating the structure of AAHA.

The Frederick T. Muncie Gold Award is presented to a member who has earned a total of 75 member points. This award honors Frederick T. Muncie, an organizing member of the AAHA, and the first president of the association (1947-1949). Muncie also assisted in the organization of the first AAHA chapter (First Illinois).

The Founders Medal of Honor was added in 1986 and is conferred by nomination of the Chapter Board of Directors. This prestigious award recognizes an individual who

has been actively involved in HFMA for at least three years after earning the Muncie Gold Award, has provided significant service at the chapter, regional and/or national level in at least two of those years, and remains a member in good standing. A chapter may nominate members for this award at any time during the year.
