Considering Certification?

Are looking to set yourself apart within your organization or find a new position within the healthcare industry? Would you like to become one of the healthcare finance professionals to whom others turn for trusted advice? If so, it may be time to consider becoming a *Certified Healthcare Financial Professional (CHFP)*.

Regardless of career stage, there are benefits to becoming a CHFP. Early in your career, you'll set yourself apart by demonstrating a commitment to the field of healthcare finance and continuing professional education. Mid-career professionals will better prepare themselves to lead healthcare organizations through change while managing financial resources responsibly. Seasoned executives can lead by example through mastery of new domains, including the latest payment models, risk mitigation techniques and strategic financial planning topics.

Currently, within the Northeast Ohio HFMA Chapter of 383 members, just 32 professionals have earned this highly-respected certification. Will you be next? Are you ready to become a CHFP? To become a CHFP, a candidate must develop a body of knowledge across a wide range of healthcare finance topics. When fully prepared, candidates must demonstrate mastery of this body of knowledge by successfully completing an exam and be capable of applying the knowledge to real world



situations through case studies. The entire process is self-paced and online, so there is no need for travel.

Healthcare Financial Management Association (HFMA) members can earn the certification for \$599. Individuals who are not HFMA members can enroll in the program and obtain membership for \$749. Certified Healthcare Finance Professionals must maintain certification by completing 60 contact hours of continuing professional education every 3 years and by remaining an active member of HFMA.

The program requires successful completion of two modules:

Module I – The Business of Healthcare: This module is a healthcare finance overview and includes risk mitigation, evolving payment models, healthcare accounting and cost analysis, strategic finance and managing financial resources. This is a self-paced learning program, which typically requires a minimum of 14 hours of dedicated study time and concludes with a 75-question, 90-minute exam.

Module II – Operational Excellence: This module includes exercises and case studies on the application of healthcare business acumen. The assessment includes 8 case studies with 7 questions each and must be completed within 3 hours. Both modules can be completed entirely online.

Program Recaps

Dessert and Dialogue – Exploring the Pathways to Healthcare – October 8, 2018

NEO HFMA Chapter held a joint event with Baldwin Wallace University on the BW campus. The event was free to registrants and open to both BW students as well as HFMA members as an early careerist introduction. There was a panel discussion moderated by Tom Campanella, Director of BW's Health Care MBA. The panel included:

Back to Our Roots: An Accounting & Finance Update – November 14, 2018

The 100th Bomb Group in Cleveland was host to the 2018 Back to Our Roots Conference. This was a full day of education and was well attended.

Bob Gross from the Cleveland Clinic was the first speaker to provide insight on how he and his team transformed Revenue Cycle Analytics to save millions. He discussed how metrics were reported in the past and the transformation in systems to provide more relevant and up to date information in real time that allowed the Cleveland Clinic to react immediately to denials and other revenue detractors. This increased the overall collectability as well as the raw amount of collections.

Following that, Tery Kennedy and Brian Francesangelo from Ernst & Young provided an accounting update for healthcare. There was discussion on tax law changes as well as key accounting changes that may affect some or all providers.

Lewis Baum then frightened the entire room discussing digital security. His tips and instruction addressed personal digital security such as passwords and protective sleeves that deter RFID detectors to how the security applies to medical records and hospital systems. Mr. Baum provided some insight into some of the engagements he has performed with health care systems and offered advice and guidance to the group on what he has learned.

Next on the agenda was a Medicare Cost Report 101 primer given by Bill Emrhein of Emrhein & Associates. It was an overview of the Medicare Cost Report and its schedules. It was a good presentation for those new to healthcare or those needing a refresher on cost reporting. Bill touched on how the cost report impacts reimbursement and thus its importance.

Following lunch, the attendees got a presentation on Optimizing the Accounting Close and Financial Reporting given by Jeff Chalmers of Silicon Valley Accountants. Jeff talked about the challenges of month end close from the accountant's perspective. With expectations from leadership to produce reports immediately, accounting must be able to streamline processes and utilize technology to meet those expectations.

The final speaker of the day was the Keynote. Bernie Moreno, president of Collection Auto Group spoke on Customer Satisfaction and how the example is set at the top.
